


APPROVAL SHEET

1. Approved minutes of the September 10 and September 17, 2014 board meetings.
2. Approved Referral Agreement between the Aliquippa School District and Drug and Alcohol Services of Beaver County, Inc. Agreement is for a period of two (2) years.
3. Approved Collective Bargaining Agreement (CBA) between the Aliquippa School District and the Aliquippa Education Association (AEA) for a four-year (4) period, effective July 1, 2014 through June 30, 2018.
4. Approved approve letter of agreement between the Aliquippa School District and The Meadows Psychiatric Center and Universal Community Behavioral Health for the 2014-2015 school year.
