


APPROVAL SHEET

The following is intended as a summary of significant actions taken at the Regular Board Meeting of the Board of Directors of the Aliquippa School District held on Wednesday, March 17, 2021. The meeting was called to order at 6:01 p.m.

1. Approved the minutes of the February 10 and 17, 2021 Board meetings.
2. Approved submitting an application to the Beaver County Community Development Block Grant Program to refurbish or to demolish the visitors grandstand at the football stadium.
3. Approved Letter of Agreement with The Meadows Psychiatric Center for the 2021-2022 and 2022-2023 school years.
4. Approved the 2021-2022 school calendar.

8. Adopted the 2021-2022 BVIU's General Operating Budget by the Aliquippa School District. The budget total is \$1,490,231.00. This is a decrease of \$117.00. The District's contribution is \$5,331.30. This is an increase of \$65.63.
