- 1. Approved the minutes of the September 11 and 18, 2019 Board meetings.
- 2. Reaffirmed the District's Non-Discrimination Policy as required by Title VI and Title IX of the Education Amendments of 1972 and Section 504 of the Rehabilitation Act of 1975. Said policy to be advertised in the Beaver County Times.
