The following is intended as a summary of significant action taken at the Voting Board Meeting of the Board of Directors of the Aliquippa School District held on Wednesday, November 17, 2021. The meeting was called to order at 6:13 p.m.

- 1) Approved the minutes from October 13th & 20th, 2021 board meetings.
- 2) Approved the Wilson Group Copier Contract for a 60 Month lease at \$4,100.00 per month. The contract terms provide a monthly savings of \$115.00, an annual savings of \$1,368.00 and a 5-Year savings of \$6,930.00. The Wilson Group will PAYOFF OF ALL EXISTING LEASE OBLIGATIONS. The Wilson Group will also make a one-time \$25,000 contribution to the district's construction fund and a \$2,000.00 contribution to the district's scholarship fund each year of the contract.

- 8) Approved the Mileage Reimbursement for Home and School Visitor Mrs. Hughston-Roberts in the amount of \$49.05.
- 9) Approved the mileage reimbursement for Brandon Ledonne in the amount of \$45.78.
- 10) Approved the reimbursement of petty cash in the amount of \$498.18 for the damage basketball hoop. Annual Bulk mail fee in the amount of \$265.00 and Staff Gift Card reward in the amount of \$50.00.
