


## APPROVAL SHEET

The following is intended as a summary of significant actions taken at the meeting of the Board of Directors of the Aliquippa School District held on Wednesday, January 21, 2015 at 6:01 p.m.

1. Approved minutes of the December 3, 2014 Board meeting.
2. Ratified continuation of the purchase of natural gas from Direct Energy Business for a term of two years (24 months), effective September 1, 2015 through and including August 31, 2017, at the consortium rate of \$-0.780/Dth plus the commodity charge for the month.
3. Approved agreement with Dr. Daniel Christo for ACCESS billing review, effective July 1, 2014 through and including June 30, 2017. The monthly cost for the agreement is \$200.00.
4. Approved renewal of Mr. David A. Wytiaz as Superintendent for a term of (3) three years, effective July 1, 2015 through June 30, 2018.
5. Ratified enrollment with Energy Curtailment Specialists, Inc. (ECS) to serve as Curtailment Service Provider with PJM Interconnection, LLC for the Energy Demand Response Program.

  - b) Report of Taxes Collected – November and December 2014.
  - c) Report of Delinquent Property Tax Collections – November and December 2014.

7. Ratified General Fund disbursements in the amount of **\$1,144,895.91** for December 2014.
8. Approved General Fund disbursements in the amount of **\$413,811.98** for January 2015.
9. Approved Cafeteria Fund disbursements in the amount of **\$151,064.79** for January 2015.
10. Approved approve post-season playoff pay adjustment for the 2014 Football season.
