- 1. Approved minutes of the February 8 and February 15, 2017 board meetings.
- 2. Adopted the 2017 2018 Beaver Valley Intermediate Unit's General Operating Budget by the Aliquippa School District. The Budget total is \$1,677,962. There will be no increase in the districts contribution.
- 3. Approved a five (5) year contract with eSchoolView for the district website services beginning July 1, 2017 through and including June 30, 2022. There is no increase in the service (\$286.00/month). Funds will be paid through the Technology Budget.
- 4. Ratified In-School Suspension Program for the Aliquippa JSHS effective with the start of the first day of school on August 22, 2016.
- 5. Nominated Sandra Gill for a three (3) year term as the district representative on the Beaver Valley Intermediate Unit Board of School Directors effective, July 1, 2017 through and including June 30, 2020.

- 8. Approved General Fund disbursements in the amount of \$425,476.23f or March 2017.
- 9. Ratified General Fund disbursements in the amount of \$694,895.83 for February 2017.
- 10. Ratified Cafeteria Fund disbursements in the amount of \$86,682.11 for February 2017.
- 11. Approved Cafeteria Fund disbursements in the amount of \$59,414.24 for March 2017.
- 12. Approved the audit report prepared by Mark C. Turnley, CPA for the Aliquippa School District for the year ending June 30, 2016.

- 13. Approved revised salary for Mr. Vashawn Patrick, Boys and Girls Assistant track coach at a rate of \$3,227.90.
- 14. Approved the Football Summer Conditioning Program, beginning June 26, 2017 through and including August 11, 2017. The cost of the program remains the same as the 2015-2016 year at a rate of \$3,570.00. Funds will be paid from the Athletic budget.
- 15. Approved Ms. Donna Richey as a volunteer coach for the Girls Basketball team for the 2017-2018 Season.
- 16. Approved Mr. Maurice Carey as a volunteer coach for the 2017 Football Season.
- 17. Ratified Ms. Miyako Powell and Aliquippa Royals All Star Cheer team practice in the auxiliary gym February 4, 2017-April 22, 2017 (Saturdays only) at a rate of \$100.00 from 1:00p.m- 3:00p.m.
- 18. Approved #B24Strong to use the JSHS March 31- May 26, 2017 (except March 24, April 14 and May 5) as a movie night as a fundraiser for Quipettes and #B24Strong. Security will be provided by Ms. Gordon and the committee. All custodial/maintenance fees are the responsibility of #B24Strong approximately \$135.00 per event.
- 19. Approved AAU Pittsburgh Air to use the ES gym March 16, 23 and 30<sup>th</sup>, April 6, 20 and 27 and May 4, 11, 18 and 25 from 7:00p.m-9:00p.m. at a rate of \$100.00. A certificate of liability must be provided.
- 20. Approved WPPC to use the ES cafeteria, gym and playground from June 19-July 28, 2017 from 8:00a.m-3:00p.m, for the STEP Health and Wellness program. There is no cost to the district.
- 21. Approved payment to Guy's Mechanical Systems from the 2010 PLGIT Construction Fund for installation and movement of compressors at a cost of \$2,580.00.
