3. Approved a Memorandum of Understanding with the City of Aliquippa Police Department as required by the Safe Schools Act.



10. Approved Services Agreement Reinstatement with The Omni Group for the continuation of 403(b)/457(b) administration services, effective July 1, 2015 through and including June 30, 2016, at a cost of \$1,644.00. There is no cost increase.

11. Approved agreement with the Meadows Psychiatric Behavioral Health Center at a rate of \$60.00/day for educational services on an as needed basis. The agreement may be terminated by either party with a 30 day written notice.
