

## APPROVAL SHEET


The following is intended as a summary of significant action taken at the Reorganization Board Meeting of the Board of Directors of the Aliquippa School District held on December 7, 2022. The meeting was called to order at 6:01 p.m.

- 1) Mrs. Tina Price-Genes was reappointed as President of the Aliquippa School District Board of School Directors..
- 2) Mrs. Nicole Bible was reappointed as Vice - President of the Aliquippa School District Board of School Directors.
- 3) Approved the minutes from the November 16, 2022 Board Meeting.
- 4) Approved a 4-hour comprehensive planning session Thursday December 29th at the Aliquippa Elementary School. The team of 10 staff members will be paid \$30 an hour not to exceed \$1,200.
